

## WIN DAD A \$150 BUNNINGS VOUCHER FOR FATHER'S DAY 2020 TODDLE PROMOTION

### CONDITIONS OF ENTRY

1. Information on how to enter, mechanics of entry and the prize, form part of these Conditions of Entry. Entry into the promotion is deemed acceptance of these Conditions of Entry. Entry is via internet only.
2. This is a game of chance and skill plays no part in determining the winners.

### PROMOTIONAL PERIOD

3. The promotion commences at **08:00am (AEDT)** on **25/08/2020** and ends at **10:00pm (AEDT)** on **03/09/2020** (inclusive) (**Promotional Period**).

### ELIGIBILITY

4. Entry is strictly limited to residents of Australia aged 18 years or older, who are located in Australia during the Promotional Period and who, in the event they are selected to participate in Toddle Promotion, are able to use the e-coupon prize.

(together, **Entrants**).

5. The directors, management and employees (and their immediate families) of the Promoter, its related entities, printers, suppliers, providers and agencies whom are directly associated with the conduct of this promotion are ineligible to enter the promotion. Immediate family means any of the following: spouse, ex-spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or 1st cousin.

  - c. if contacted by a representative of the Promoter, provide additional information as directed, such as the Entrant's full name, email address, Instagram handle (together, an **Entry**).

## **GENERAL**
